
#### DEWATERING UPDATE

## **Permitting** Update

## State and federal permits submitted for potential redevelopment of the Kings Mountain Mine

Albemarle has completed the submission of several state and federal permits to pursue the redevelopment of the Kings Mountain Mine. This is a key milestone in the mine's potential redevelopment. With these permit submissions, the company proceeds into a multiyear permitting phase. In addition to the successfully securing the necessary permits, the project is subject to a final investment decision by the company prior to commencing construction.

Albemarle must secure a series of over 30 different approvals from the City of Kings Mountain, several divisions within the State of North Carolina and the federal government, to construct and operate the proposed mine. Covering areas such as water, air, noise and land use, the permit review process is subject to agency timelines that may last two years or more and is expected to include extensive agency and stakeholder review and comment.


"Completing the submission of our state and federal permit applications was a key focus area for the project this year and marks a significant milestone in our journey to redevelop one of the best lithium resources in the world," said Albemarle Senior Permitting and Sustainability Manager Erik Carlson. "These permit applications are supported by thousands of pages of environmental analysis that started over two years ago and include data on flora, fauna, water quality, historic resources, air quality and continues to this day. We remain steadfast in our efforts to advance this project through the implementation of industry best practices for responsible mining and meeting the high standards required by governmental agencies."

In addition to the preparation and submittal of permit applications, Albemarle continues a comprehensive stakeholder outreach program. It operates a Project Center in downtown Kings Mountain, sharing details of the project through a monthly Community Advisory Panel, periodic townhalls and open house events. 66 These permit applications are supported by thousands of pages of environmental analysis that started over two years ago and includes data on flora, fauna, water quality, historic resources, air quality and continues to this day.



Earlier this year, Albemarle also commenced the public participation portion of a voluntary Environmental and Social Impact Assessment (ESIA). The assessment is a key element to align the mine's redevelopment with the Initiative for Responsible Mining Assurance's Standard for Responsible Mining, the most comprehensive set of globally recognized standards for responsible mining.

The ESIA seeks to develop environmental and social management plans to minimize adverse impacts and enhance benefits for the surrounding communities. Albemarle plans to publish and share the assessment's findings and anticipated management measures with the community stakeholders throughout 2024 and 2025.


